5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Mayor Schneider Mayor Schneider mentioned that his report was included in the packet.
- Law Director Bond Nothing to Report
- Chief Barfield Chief Barfield reported that his department participated in the Pete Soto Chili Cook Off and came in 4th place. He thanked Geyer's, Steve Maurer, and his employees for their donation to the cook off. He invited residents to the Heroin Initiative at the United Methodist Church at 6:30 PM Tues. Feb. 7th.
- Finance Director Hales Ms. Hales reported that the Online Bill Pay was back up and running on the website. Ms. Dronsfield had a question regarding the mowing liens; Ms. Hales answered her question.
- Village Manager Dupee Mr. Dupee reported that the school deed has been completed and mentioned that he and Mayor Schneider would be meeting with the school board on Thursday. Mr. Hartman reminded council that the community should be involved with park planning and mentioned that several residents were interested in being on a committee for the park planning.
- Main Street Wellington Main Street Wellington Director Arntz gave an update on coming events and mentioned that there is a new business, The Paint Factory, coming

to town, and will be opening next month.

- Finance Mr. Hartman reported that the committee had met prior to the council meeting and discussed the final budget revisions, Wichert Ins. renewal for \$112,615.00 and an ordinance that will allow the General Fund to loan \$100,000 to the Sewer fund.
- Police Mr. Wells reported that the committee had met prior the council meeting and discussed monthly and yearend reports and a proposal from Chief Barfield to join Lexipol, a risk management company who will write and update policies for the Police Dept., yearly. He mentioned that the program is similar to the village's ordinance codification process. Motion by Wells, 2nd by Hartman to accept the proposal from Lexipol for \$5,139.00. - Public Works Ms. Dronsfield reported that the committee met prior to the council
 meeting and discussed an ordinance for cooperative state purchasing, and a new
 concession stand and restrooms near the soccer fields at the Rec. Park. She also
 mentioned that the new baseball field would be ready to play on this spring.
- Utility Mayor Schneider reported that the committee would meet prior to council on Feb. 21st.
- Ordinance Mr. Rowland reported that the committee met briefly prior to the council meeting and will be discussing the light ordinance at the next meeting on March 6th.
