5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Law Director Bond Nothing to Report
- Chief Barfield Chief Barfield reminded residents that with warmer weather there would be more children outside and asked drivers to be cautious.
- Finance Director Hales Ms. Hales reported that the auditors were still in and out and would likely be finishing up soon. She further reported that she would be in Columbus two days for state training.
- Village Manager Dupee Mr. Dupee reported that the new email exchange server had been completed and asked any council members having problems to get in touch with him

6. REPORTS OF COMMITTEES

- Finance Ms. Denes reported that the committee would meet on April 17th. She further reported that the Planning Commission had granted the final approval for TSC to proceed.
- Police Mr. Wells reported that the committee had met prior to the council meeting and discussed the radio grant application, which was not successful. He mentioned that they will apply again if the grant becomes available in the future. Motion by Wells,

2nd by Denes to hire Jolene Mahek as a part time dispatcher at \$13.64 per hour, with a six month probationary period, effective pending testing. Roll call vote was taken with all members voting "yes".

- Public Works Ms. Dronsfield reported that the committee had met prior to the council meeting and discussed adding a youth football field at the Rec. Park near the t-ball fields. She further reported that they had received word that the Eagles will be donating \$1,500.00 toward the purchase of a PA system at the new baseball field. Ms. Dronsfield reminded residents that the back gate to the Rec. Park had been locked, however, would be open during tournaments. She announced that the village would be utilizing the sidewalk replacement program this year, and asked any resident interested to download the brochure off of the village website or contact the Public Works Dept. Ms. Dronsfield reported that the Cemetery Board would be moving forward with the plans for a cremation garden and columbarium on the old Trails End property. Mr. Wells had concerns about the large tree in that location which is one of the largest in Lorain County; Ms. Dronsfield said they would be leaving the tree as is.
- Utility Mr. Hartman reported that the committee met prior to the council meeting and discussed an increase in the refuse rates by \$1.50 per household, per month, and mentioned that the ordinance would go three readings. He stated that the committee had also discussed the Adams St. assessment process and announced that assessment letters would be going out to property owners this week.
- Ordinance Mr. Rowland reported that the committee had met prior to the council
 meeting and briefly discussed the tree lawn ordinance, the light ordinance and a
 possible drone ordinance. He further reported that the committee would be discussing
 the vacant building registry in the future.
- Personnel Mr. Bughman reported that the personnel committee will be meeting in the future, as Mr. Dupee is still preparing for a discussion.
