- 3. APPROVAL OF MINUTES. Ms. Dronsfield mentioned that she was marked present in the minutes and asked that the minutes be revised to show that she was absent. FINANCIAL REPORTS** Ms. Denes and Mr. Hartman had questions regarding the bills; Mr. Dupee and Ms. Hales answered the questions, and those they could not answer, would be investigated and reported back to them. 5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Mayor Schneider
- Law Director Bond . Nothing to report.
- Chief Barfield. Chief Barfield reported that the village had survived the storm on Sunday, and thanked the Safety Services, the Electric Dept. and Public Works for the prompt clean up. Mr. Wells asked Chief Barfield why the siren signaled after the storm had supposedly passed; Chief Barfield advised Mr. Wells that Fire Chief Wetherbee had been notified of a funnel cloud siting at SR 58 and Merriam Rd. and he signaled the siren. Mr. Hartman mentioned that he had no problem hearing the siren inside of his home, and thanked Chief Barfield and all the others for the collaborative work on the notification system.

- Finance Director Hales. Ms. Hales mentioned that her report was included in the packet and she would be happy to answer any questions. Ms. Denes congratulated Ms. Hales on her training certification and encouraged Ms. Hales and her team to attend training as often as possible. Ms. Denes congratulated Jeff Lopez and Steve Norton on their Class II licenses.
- Village Manager Dupee. Mr. Dupee reported that he had been working with Ms. Hales on the 2018 budget and would like to schedule a work session for November 13th or at 5:00 PM on November 20th. Council agreed to hold the work session on Nov. 20th prior to the council meeting. Mayor Schneider asked Clerk O⊕rien to notify the Park Planning Committee that the meeting would be cancelled and moved to December 4th. Mr. Dupee reported that the underpass pump station repairs had been completed, and will begin the process of transferring ownership and maintenance to the village.
- Public Participation None
- Main Street Wellington. Director Arntz reported that Small Business Saturday is on November 25th. She further reported that she had 26 confirmed popup shopsqduring the event, from 11 AM. 3 PM, and encouraged residents to shop local on Saturday Nov. 25th. She mentioned that Main Street Wellington was having a membership drive, and she had applications at the MSW office.

6. REPORTS OF COMMITTEES

- Finance. Ms. Denes reported that the committee will meet on Dec. 4th prior to council. She mentioned that the Fire Board met on November 1st and reported that they made repairs to the building, due to the Depot St. fire. She mentioned that the Planning Commission met and provided final approval to Mercy, who held a ground breaking ceremony. She further mentioned that they also gave the approval for Dr. Palls improvements on W. Herrick Ave. Ms. Denes reminded residents to vote tomorrow.
- Police. Mr. Wells reported that the committee met prior to the council meeting and discussed the dog ordinance which has been referred to ordinance committee. He further reported that they discussed personnel issues; Motion by Wells, 2nd by Hartman to accept the resignation of Officer David Munos, effective October 23rd. Roll call vote was taken with all members voting %es+ Motion by Wells, 2nd by Denes to appoint Shirley Gansor as an Auxiliary Officer, effective immediately. Roll call vote was taken with all members voting %es+ Ms. Denes thanked Ms. Gansor, who is a dispatcher at the Police Dept., for volunteering for the Auxiliary.
- Public Works. Ms. Dronsfield reported that the committee met prior to the council meeting and discussed the asphalt project, which is on hold, possibly until next year. She mentioned that they also discussed the clock tower cleaning, auxiliary building repairs, and hydrant flushing which will begin this week. She mentioned that the Cemetery Board will meet on Nov. 14th at 9:30 AM.
- Utility. Mr. Hartman reported that the committee meeting scheduled for Nov. 20th had been cancelled. He further mentioned that the Ambulance board meets on the second Tuesday, and congratulated the SLCAD, as they were the winners of the Firefighters Chili Cook-off.
- Ordinance. Mr. Rowland reported that the committee met prior to the council meeting and discussed revising the lighting and illumination ordinance. He mentioned that Poggemeyer Design Group would be consulted, before moving forward with an ordinance. He reported that the committee reviewed the dog ordinance, which was refered to them by the Police Committee; the ordinance will have a first reading tonight.
- Personnel. Mr. Bughman reported that the committee will meet on Dec. 4th if there is business to discuss. Mayor Schneider mentioned that it may be time to review the Personnel Policy Manual.
