5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Mayor Schneider
- Law Director Bond . Nothing to Repot
- Chief Barfield . Chief Barfield reported that Auxiliary Captain Larry Querin would be retiring after 20 years, 5 months with the Wellington Auxiliary. He thanked Mr. Querin and stated that Mr. Querin would be missed.
- Finance Director Hales. Ms. Hales mentioned that her report was included in the packet and she would be happy to answer any questions. Ms. Dronsfield thanked Ms. Hales and Mr. Dupee for all of their hard work on the 2018 budget.
- Village Manager Dupee. Mr. Dupee mentioned that his report and the department head reports were included in the packet. He further mentioned that there was an error in his report, under Ground Lease Agreement Extension, it read that Crown Castle would like to extend the cell tower lease from 20 years to 30 years, and increase the lease income to \$860.00 per month without a 5% escalator; it should read with a 5% escalator every 5 years. Mr. Dupee reported that there were solicitation calls going out to village residents, regarding AEP. He asked

- residents to disregard the solicitation as the village does not use AEP; the village has a local municipal electric system.
- Public Participation. Ayers Ratliff from 340 Fieldstone Ct. mentioned that his organization had raised \$5,000 for Tyson McKinleys family. He asked Mayor Schneider to consider honoring Morris Furcrons 90th birthday on December 29th, perhaps with a Morris Furcron Day. Mayor Schneider reported that he would speak with Mr. Ratliff further about honoring Mr. Furcron. Mr. Ratliff thanked Mr. Bughman for all of the work he does for the schools.
- Main Street Wellington. Main Street Wellington Director Arntz reminded residents that they would be decorating the Christmas tree in the gazebo on Tuesday November 28th, and asked anyone who would like to help, meet at the gazebo in front of the Town Hall. She also asked residents to call her with names of veterans, EMS or fire that needed to be added to the tree. She mentioned that the Kurtz Christmas Tree Farm would be donating the Christmas tree once again, and added that the Kurtz would be celebrating 50 years of selling Christmas trees. Ms. Arntz reminded residents about Small Business Saturday, on November 25th, and mentioned that they had 30 vendors participating.
