## 5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

## 6. REPORTS OF COMMITTEES

- Finance Mr. Hartman reported that the committee will meet prior to council on January 16<sup>th</sup>.
- Police. Mr. Wells reported that the committee met prior to council and discussed the proposed tiered payroll system, and an ordinance to sell a vehicle at internet auction. Motion by Wells, 2<sup>nd</sup> by Hartman to extend the probationary period for Kayla Chrosniak from January 10, 2018 through April 10, 2018, with no change in pay. Roll call vote was taken with all members voting %es+.
- Public Works. Ms. Dronsfield reported that the committee met prior to the council meeting and discussed winter projects including, the soccer pavilion, and replacing basketball hoops in the Town Hall Gym.
- Utility. Mr. Bughman reported that the committee would meet on January 16<sup>th</sup> prior to council.
- Ordinance. Mr. Wells reported that the committee met prior to council and discussed updating the lighting ordinance, through Planning Commission. Mr. Wells mentioned that council had met for a special organizational meeting at 5:30 PM to appoint committees and elect a council president. He further mentioned that it was guite an improvement over previous years, and that it worked out very well.

- Personnel . Mr. Rowland reported that they would be holding a work session to discuss employee succession planning. Mr. Hartman noted that Mr. Rowland had four committee appointments, and recommended that Mr. Bughman take Mr. Rowlands place on the Public Works Committee. Motion by Hartman, 2<sup>nd</sup> by Wells to have Mr. Bughman replace Mr. Rowland on the Public Works Committee. Roll call vote was taken with all members voting %es+ Mayor Schneider suggested that the tentatively scheduled work session set for January 23<sup>rd</sup>, be moved back a week to possibly January 30<sup>th</sup>, as Main Street Wellington will be holding their annual meeting that evening; council agreed, as Mr. Dupee needed some time to gather information. Council will discuss the date for the work session further at the January 16<sup>th</sup> meeting.
- Mayor Schneider gave the floor to Chief Barfield and the Police Department, as they had awards to present. Chief Barfield announced that three years ago, the Police Department began selecting an Officer and Dispatcher of the year award, and mentioned that it was a difficult choice. He asked Carole Weegmann to come forward and presented her with the Dispatcher of the Year Award. Ms. Weegmann was met with applause. Chief Barfield asked Officer Daher to come forward and presented him with the Officer of the Year Award. Officer Daher was met with applause.

### 9. NEW BUSINESS

- Park Committee Mayor Schneider reported that the Park Committee, consisting of 13 members, had been appointed at the first of last year and had worked diligently with Eric Brubeck, from Brubeck Designs, to produce a plan for the old McCormick Middle School site. Mayor Schneider introduced Mr. Brubeck who reviewed the final plan with council. Mayor Schneider named the members of the Park Committee which included: the late Fred Alspach - Committee Chairman, Susan Alspach, Steve Dupee, Gene Hartman, Ted Hyde, Vanessa Klesta, Terry Mazzone, Father Reymann, Hans Schneider, Tim Simonson, Patty Sumpter, John Westfall, and Ralph Wright. Motion by Hartman, 2<sup>nd</sup> by Rowland to accept the recommendation of the Park Planning Committee, and accept the rendering of the Wellington Park, and forward it to the Planning Commission. There was some discussion about enacting the plan, before being able to review the information first, Mr. Hartman rescinded his motion, Mr. Wells had reservations about adopting the plan, and asked whether the budget figures would be appropriated; Mr. Hartman and Mayor Schneider assured Mr. Wells that the money was not to be appropriated. Mr. Brubeck added that the park could be built in phases, as money allows. Mayor Schneider mentioned that they would be seeking grants and donations to fund the park. Mr. Wells suggested resolving to receive the plan tonight, to thank the committee for their hard work, and then send it to planning. Motion by Hartman, 2<sup>nd</sup> by Rowland to accept the plan received tonight, to thank the committee for their hard work, and to send the plan to the Planning Commission. Roll call vote was taken with all members voting ‰es+
- Bicentennial Committee Mayor Schneider introduced the members of the Bicentennial Committee: Al and Barb Leiby, Jenny Arntz, and Laura Braddock. He displayed the Bicentennial Calendars that the committee designed, and mentioned that the calendars are free and available at Main Street Wellington, the Spirit of \$\overline{q}\$6 Museum and at the Town Hall. He mentioned that the committee had met its donation goal of \$25,000. He read through the list of events and their dates and mentioned that the majority of events are free or very low cost to attend. He thanked the sponsors, the Lindley Center and the committee for all of their hard work. The committee was met with applause.
