- Village Manager Dupee. Mr. Dupee mentioned that his report and those of the Department Heads were included in the packet and offered to answer questions. Ms. Dronsfield had a question regarding CMI, which Ms. Hales mentioned in her report; Mr. Dupee answered her question.

- Main Street Wellington. Ms. Arntz congratulated council on the passage of Issue 34. She reported that Small Business Saturday would be on November 23rd and encouraged residents to shop local. She mentioned that there were new shops opening up downtown including the Sweetshop bakery, Charmed Farmhouse, Painted Porch Primitives, the Lazy Lizzard, and a flooring, kitchen and bath store opening up in the spring.

6. REPORTS OF COMMITTEES

- Finance . Mr. Hartman reported that the committee will meet on November 19th at 5 PM.
- Police . Mr. Wells mentioned that the committee met prior to the council meeting and discussed

personnel. Motion by Wells, 2nd by Bogan to remove dispatcher Jen Brasee from probation and increase her hourly wage to \$14.46, effective the next full pay. Roll call vote was taken with all members voting ‰es+ Motion by Wells, 2nd by Bogan to accept the resignation of Full Time Officer Sean Kneisel, effective November 1, 2018. Roll call vote was taken with all members voting ‰es+ Motion by Wells to hire Sean Kneisel as Part Time Officer, at \$21.36 per hour, effective November 1, 2018. Roll call vote was taken with all members voting ‰es+ Motion by Wells, 2nd by Bogan to accept the resignation of dispatcher Richard Hall, effective December 21, 2018. Roll call vote was taken with all members voting ‰es+ Motion by Wells, 2nd by Bogan to accept the resignation of part time Officer Matt Mijamjos, effective November 1, 2018. Roll call vote was taken with all members voting ‰es+ He mentioned that the committee met in executive session to discuss property acquisition, with no action taken.

- Public Works. Ms. Dronsfield reported that the committee met prior to council where they were updated on winter projects. She mentioned that leaf pickup was in full swing, and asked residents to be patient with the leaf collection.
- Utility. Mr. Bughman reported that the committee met prior to council and discussed the Wastewater Chief Operator position. Motion by Bughman, 2nd by Hartman to promote Steve Norton to Chief Wastewater Operator at \$24.95 per hour, effective November 8, 2018. Roll call vote was taken with all members voting %es+. He mentioned that they briefly discussed the Erie St. elevated water tower inspection, and repairs would be made to the tower in 2019. He mentioned that the committee briefly discussed the condition of the Erie St. elevated water tower, and the improvements being made to the chlorine room at the Water Plant.
