5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Finance Director Pfeiffer Mrs. Pfeiffer mentioned that her report was included in the packet and offered to answer any questions.
- Village Manager Dupee Mr. Dupee mentioned that his report and those of the Department Heads were included in the packet and offered to answer any questions. Mr. Dupee reported that the Water Dept. and village staff had an excellent response to restoring the water service, after a water break left the village without water on June 20th. He commended employees, and thanked them for their excellent response to the significant water break event. Mr. Hartman mentioned that all departments worked well together and congratulated the staff for a job well done. Ms. Dronsfield agreed, and thanked Rural Water for the mutual aid. Mr. Wells had questions for Mr. Dupee concerning the Quiet Zone; Mr. Dupee reported that CSX had accepted the insurance requirements, and are now ready to schedule the work and a flagger, install the signage, and that he expected to begin the work in July. Mr. Bughman mentioned that there was a loose railroad tie at the Barker St. crossing and asked that Mr. Dupee notify CSX.
- Public Participation None
- Main Street Wellington Mrs. Arntz gave her report, and the nutrition tip from THRIVE, 'beat the summer heat'. She mentioned that the First Friday event in August would be called "Color our World in Kindness" and would be making donations for the Helping Hands Pantry.

6. REPORTS OF COMMITTEES

- Finance Mr. Hartman reported that the committee met prior to the council meeting and discussed the June financial statement, RITA collections, which are down but would hopefully rebound in August, and discussed the CARES act resolution on tonight's agenda. He mentioned that the Fire Board minutes were included in the packet and noted STAR Builders was awarded the contract for the districts expansion project.
- Police Mr. Wells reported that the committee met prior to council where Chief Barfield reviewed the

monthly report with the committee. He mentioned that there was also an executive session. Motion by Wells, 2nd by Dronsfield to promote Jeffry Mecklenburg to Sargent at \$29.02 per hour, effective after his swearing in. Roll call vote was taken with all members voting "yes".

- Public Works Ms. Dronsfield reported that the committee met prior to the council meeting and discussed ongoing projects including crack sealing, hole patching, and chipping brush. Ms. Dronsfield thanked the department for their work at the cemetery, pouring concrete and leveling dirt. She reported that the department is doing street repairs, pouring concrete blocks, and some block leveling has been performed. She mentioned that the crews are working at the Rec. Park, and the Gazebo in front of the Town Hall is being painted.
- Utility Mr. Rowland reported that the committee met prior to the council meeting. He gave a recap of the June 20th water break; on June 19th the Wellington Fire Dept. responded to a barn fire on Pitts Rd. When the hydrant was closed, it caused a water main break on a 12" main at the reservoir. He thanked Rural Water, for their mutual aid, and providing the village with 185,000 gallons of water. He also thanked the Water Dept. staff who made 1.5 million gallons of water in 37 hours. He mentioned that the OEPA has approved the Ground Storage project, which should begin sometime in the fall.
- Ordinance Mr. Bughman reported that the committee met prior to council, approved the minutes, and mentioned that there was nothing on the agenda to discuss.
- Personnel Mr. Bogan mentioned that he would like to have a meeting in August to discuss succession planning.
