- Utility Mr. Rowland reported that the committee met prior to council where they discussed Electric Dept. and Water and WW updates. He mentioned that the Electric Dept. installed a new pole, lights, and scoreboard at the Rec. Park, and took possession of the new bucket truck. He reported that the water Consumer Confidence Report would be out in April and that the departments were working on misc. projects. Mr. Rowland reported that the Ohio EPA approved the Source Water Protection Plan, and explained that the plan will increase fundability for future projects, and congratulated Mr. Frenk on the accomplishment. Mr. Rowland announced that after further review, there are no issues with ice fishing on the reservoir while the Water Dept. is pumping water.

He mentioned that there would be a few revisions on Ordinance 2021-07 for the second reading.
