- Finance Director Pfeiffer Mrs. Pfeiffer mentioned that her memo was included in the packet and offered to answer any questions. She thanked the residents for being patient and understanding as they resolved the problems with the Utility billing software.
- Village Manager Dupee Mr. Dupee mentioned that his report and those of the department heads were
  included in the packet and offered to answer any questions.

- Main Street Wellington MSW Director Arntz reported that the flower pots had been planted and placed in the CBD and mentioned that the Cannas would be planted in the rest of the pots at a later date. She mentioned that they had an Adopt a Pot program where 10 of the flower pots had been adopted for \$100.00 per pot. She mentioned the First Friday event on June 4<sup>th</sup>, which was sponsored by the Spirit of 76 Museum, and reported on a few of the July 3<sup>rd</sup> festivities.

## 6. REPORTS OF COMMITTEES

- Finance Mr. Hartman reported that the committee met prior to council and discussed the 214 Main St. property, and had an Executive Session. Motion by Hartman, 2<sup>nd</sup> by Dronsfield to hire Cullen Grude as Finance Associate at \$18.61 per hour effective June 14, 2021. Roll call vote was taken with all members present voting "yes".
- Police Mr. Wells reported that the Committee will meet prior to council on June 21<sup>st</sup>. Motion by Wells, 2<sup>nd</sup> by Hartman to hire Nicole Sklenica as full time dispatcher at \$17.81 per hour effective after testing.

Roll call vote was taken with all members present voting "yes". He mentioned that the department still needed to hire another part time dispatcher.

- Public Works Ms. Dronsfield reported that the committee met prior to council where Mr. Brasee updated the committee on recent projects. She mentioned that there will be a plan coming soon for sidewalk repair, and tree replacement in the Central Business District. Motion by Dronsfield, 2<sup>nd</sup> by Bughman to hire Andon O'Neal, Madalyn Mull, and Tyler Moody as seasonal summer employees at \$11.00 per hour effective immediately. Roll call vote was taken with all members present voting "yes".
- Utility Mr. Hartman reported that the committee met prior to council. He mentioned that Greg Frenk updated the committee on repairs needed at the reservoir for insurance purposes. He thanked Dave Bealer, and Greg Frenk for their reports, and mentioned they are very knowledgeable.
- Ordinance Mr. Bughman mentioned that the committee cancelled the meeting which was scheduled prior to council.
- Personnel Mr. Bogan reported that the committee met prior to council and discussed succession planning, and met in executive session. He mentioned that the committee would need to review wages, across the board, in the future.
