# 5. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

- Mayor Schneider Mayor Schneider thanked Kiwanis for hosting the State of the Village, which he stated, was very well attended. He mentioned that it is also a fundraiser for Kiwanis, and they will be using the money to purchase playground equipment.
- Law Director Bond Nothing to report

- Finance Director Pfeiffer Mrs. Pfeiffer mentioned that her summary was included in the packet and offered to answer any questions. She further mentioned that she will be on vacation next week.
- Village Manager Greever Mr. Greever reported that they had received bids on the bonds, and secured a 2.48% interest rate, with a 5 year call option. He thanked Vanya, Mayor Schneider, and Mr. Hartman for their help. Mayor and Council thanked Mr. Greever and Mrs. Pfeiffer for their work and timeliness of the matter. Mr. Greever answered questions from Mr. Bughman regarding the concession stand at the Rec. Park.
- Public Participation Resident Bill Neff had questions and remarks for the Mayor and Council, including empty downtown business fronts, how the village salts their streets, and the condition of the village streets and the possibility of a street repair levy; Mayor Schneider, Council, and MSW Director Arntz answered his questions.
- Main Street Wellington MSW Director Arntz gave her report which included an Easter Egg Scramble, an
  Easter Egg decorating contest, and a chili cook-off fundraiser at the Town Hall. She mentioned the
  Gazebo Garden Walk on May 7<sup>th</sup>, and the next 1<sup>st</sup> Friday on May 6<sup>th</sup>.

## 6. REPORTS OF COMMITTEES

- Finance Mr. Hartman reported that the committee will meet on April 18<sup>th</sup>, which is also tax day. He
  mentioned that SLCAD will be holding interviews this Friday looking for a replacement for Director Gentry
  whose last day is June 1<sup>st</sup>.
- Police Mr. Wells mentioned that the committee will meet prior to council on April 18th.
- Public Works Ms. Dronsfield reported that the committee met prior to council and discussed funding options for a new \$39,500 snow blower which is needed for the coming winter. She mentioned that Rebecca Scott was in attendance to discuss the possibility of a portable ice rink in Union School Park. Motion by Dronsfield, 2<sup>nd</sup> by Wells to raise the curb but fee, from \$500 to \$700, effective immediately. Roll call vote was taken with all members voting "yes".

- Utility Mr. Rowland reported that the committee met prior to council. He mentioned that Steve Norton and Dave Bealer do a great job. Mr. Rowland thanked Mark Rosemark for helping out the Village once again, after his retirement. Mayor Schneider agreed.
- Ordinance Mr. Bughman reported that the committee met prior to council and discussed the new State
  of Ohio law concerning fireworks. He mentioned that those celebrating Diwali will be able celebrate with
  fireworks on the 3<sup>rd</sup> day only.
- Personnel Mr. Rowland reported that the committee met prior to council. Motion by Rowland, 2<sup>nd</sup> by Wells to promote Steve Norton to Waste Water Treatment Plant Supt. at \$65,531.20 per year, effective immediately. Roll call vote was taken with all members voting "yes". Motion by Rowland, 2<sup>nd</sup> by Wells the policy for on call pay will apply to all exempt village employees, effective immediately. Roll call vote was taken with all members voting "yes".
