AN ORDINANCE AMENDING SECTION 1175.11 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF WELLINGTON, RELATIVE TO ELECTRONIC CHANGEABLE MESSAGE SIGNS – Mayor Schneider opened the floor for discussion. Mr. Greever gave a brief overview of the ordinance and the recommendations from the Zoning Board for the legislation. Village residents Leslie Simonson, Cynthia Jones, and Becky Loughin were opposed to electronic signs in the business district.
