- 6. COMMUNICATIONS FROM MAYOR, COUNCIL, AND VILLAGE OFFICIALS

 - Finance Director Pfeiffer Mrs. Pfeiffer had nothing to add, and offered to answer any questions. She answered questions from Mr. Hartman regarding KWT that she mentioned in her report.
 - Village Manager Greever Mr. Greever thanked Council for supporting AMP in DC, and assured Council that AMP is fighting for dollars lost by the federal government reneging on the Buy America Bonds. He answered questions from Mr. Hartman regarding AMI and Town Hall meetings. - Police Mr. Rowland reported that the committee will meet on March 18 prior to council.
- Public Works Ms. Dronsfield reported that the committee met prior to council. She mentioned that Public Works is working on sanitary sewers, usual daily tasks, cleaning and painting the vault in the old Police Station, and working on the Rec. Park building. She further mentioned that the Rec. Park opens on April

- 1, and they are anticipating that the West St. project will be completed this year.
- Utility Mr. Bughman reported that the committee met prior to council where they heard reports from the Electric Dept. working at the Fairgrounds, Water Dept. performing daily operations, upcoming lead and copper testing, and the WW Departments upcoming lift station replacement project in Parkside, brushes installed in the final clarifier, and underpass pump station repairs.
- Ordinance Mr. Feron reported that the committee met prior to council and finalized the fowl ordinance which will be coming to the next council meeting. He mentioned that the cemetery clean up would be April 15 this year, due to Easter being early this year. He mentioned that the cemetery is looking for summer help.
- Personnel Mr. Rowland reported that the committee met tonight in executive session.
